At the outset the Chairman welcomed the DRC members and the observer and after that the agenda was taken up for the discussion.

Item No 1: Issue regarding M.Phil pass out researcher Ms. Shaista Akhter:

The communication received from Assistant Registrar, Research, University of Kashmir vide no: KU2024-DRES-21780 was put before the DRC members, wherein the Dean Research has sought the opinion about the instant case.

During the discussions it was informed that Ms. Shaista Akhter earned her M.Phil degree in Management Studies when Tourism programme was offered under the aegis of Department of Management Studies. Meanwhile Tourism programme was carved out of the Department of Management Studies and established as an independent department and subsequently a research centre. Ms. Shaista Akhter now plans to pursue PhD in her own subject i.e., Tourism Management in which she had her master's degree. So this committee recommended that Ms. Shaista Akhter being primarily a scholar of Tourism Management, so her M.Phil degree in Management Studies may be considered fit only for acquiring admission in PhD Tourism programme in Department of Tourism, Hospitality and Leisure Studies and she may be declared eligible for admission to PhD Tourism as and when the PhD admission notification for category like JRF/NET/SET/M.Phil shall be issued.
